The Administrator issued a UDC Code Interpretation on January 5, 2008 as provided in Article VI, Chapter 18.40 JCC in response to a request for clarification of the application of existing regulations in the Code Interpretation the Administrator determined that "DCD would require an MRL overlay to allow mining activities to exceed the 10 acre performance standard in JCC 18.20.240(1)(a)". The applicant for the Code Interpretation submitted an appeal to Jefferson County on January 11, 2008 within the 14-day comment period.


